



### Greetings From Dean Buchanan

In the fullness of a Buffalo Spring as trees bud, flowers bloom, and the snarl of snow blowers is replaced by the hum of lawnmowers, the SDM also enters its own annual cycle of renewal. Two important processes mark this cycle: Commencement for the Class of 2003 and the admission of the Class of 2007.

Commencement is one of the two most exciting moments in the academic life of our School. Through the Commencement ceremony, we celebrate the accomplishments of our students and welcome them to our profession as a new generation of alumni dedicated to meeting the future oral health care needs of the public we serve. The students and their families are rightfully proud of their achievements. The faculty shares this pride. Less than 4 years ago, the faculty greeted a new group of eager young people. Since then, the students have met the challenges associated with the best education the faculty could provide; and, in what is truly a relatively short period of time, they have been transformed by these experiences from novices to health-care professionals. Again, this year, these outstanding SDM students have enjoyed amazing success in seeking postdoctoral education experiences. Approximately 75



percent of the Class of 2003 has been accepted into either a specialty or advanced education program in general dentistry. Two will be pursuing orthodontic training; two periodontics; one prosthodontics; one endodontics; one oral medicine; and one oral and maxillofacial surgery. Thirty-nine students will be enrolling in General Practice Residencies and five in Advanced Education in General Dentistry Programs. Fifteen students have chosen private practice, and two are uncommitted. If this class follows previous patterns, approximately 75% will remain in New York—most in the Western region of the State. We know that our alumni will welcome these new dentists into their communities and assist them in the career transition from school to professional life. We also extend congratulations to the Class of 2003 with great confidence that they will sustain long UBSDM traditions by assuming future leadership roles in the dental profession.

As we bid farewell to one class, our season of renewal continues with the selection of the Class of 2007. This year, the school received 752 applications for 85 class positions. The size and quality of the applicant pool has made the admissions process extremely competitive. The average test scores for those who have been accepted to date follow: PAT -- 17.7; DAT -- 18.7; science GPA -- 3.3; total GPA -- 3.4. These outstanding academic qualifications afford us the opportunity to select from among the best and brightest applicants in the state and nation. The admissions process will culminate this spring with the final selection of the Class of 2007. Later in the summer at our Convocation ceremony, the second of the two most exciting moments in our academic life, we will formally welcome the new class to our School and our profession. In four short years, they too will be transformed into full-fledged health professionals. I look forward to future opportunities to share the achievements of this outstanding new UBSDM class with you.

# In Memoriam

Robert M. Long '52 Albert F. Lapetina '57 Sebastian Ciancio, '61& P-G Perio '66, SUNY Distinguished Service Professor in the School of Dental Medicine, received the 2003 Pharmacology, Therapeutics & Toxicology Research Award from IADR. He will receive the award, which recognizes his "significant contribution to the field of dental research," at the 81st IADR General Session, being held in June in Göteborg, Sweden.



Chair of the UB Dept. of Periodontics & Endodontics for more than 30

years, Ciancio has received numerous awards, among them the 2001 Gold Medal Award from the American Academy of Periodontology. The Gold Medal Award, the AAP's highest honor, is given annually in recognition of outstanding contributions to the field of periodontology and the diagnosis / treatment of periodontal diseases.

A member of the AAP for 35 years and past president of the association, Ciancio also received the organization's Clinical Research Award in 1996, a Special Citation in 1994 and the William J Gies Award in 1988. He is a consultant for the Journal of Periodontology and is an editor for Biological Therapies in Dentistry and Periodontal Insights. A prolific researcher, he has authored more than 100 scholarly papers. Dr. Ciancio is currently a resident of Eggertsville, NY.

# Out of the Past

The following Buffalo newspaper article (dated about 1953) was sent to us by Mr. George Richmond. Dr. Gracia A. Paxson Hackemer graduated with the Class of 1903.

### The little lady behind the big drill - a long story.

With a little whimsy, Dr. Gracia A. Paxson Hackemer of 180 Main St., Hamburg, might thus sum up her 50-year dental career. The slim lady with the white bobbed hair is Hamburg's senior dentist and still drills with the best of them.

'When I was a girl, I felt destined for dentistry and now that I'm not so young, I'd be lost without it,' says Dr. Paxson, at 75. (Most people still refer to Mrs. Hackemer as Dr. Paxson.) Gracia was 16 when she was graduated from Hamburg High School. That was back in 1895, nine years after her dentist-father moved there. That was the same year that the University of Buffalo Dental School opened its doors. But the pretty Miss Paxson had to wait a few years before she could satisfy her destiny. 'My father took me to the three-story building on Goodrich St. and Dean Barrett told me that first day that I'd get along fine if I didn't ask for special favors,' Dr. Paxson remembered. 'I've followed that advice ever since.' 'The dental building didn't look like much then, but we didn't have to wait for operating chairs,' she went on, 'I was one of three girls in a class of 70.' Thus far, Dr. Paxson hasn't seen the new UB dental buildings. She was ill at the time of the open house, but is certain 'they must be wonderful.' Of the trio of girls in the 1903 class, Dr. Paxson is the only one who practiced dentistry for any period but she doesn't claim female dental seniority. It hink Dr. Josephine A. Spillman of Tonawanda took her degree about five years before me,' she concedes. Oddly enough, while there were 21 U.B. women dental graduates from 1895 to 1903, there have been only 26 more since. After receiving her degree, Dr. Paxson joined her father and the two practiced side by side until 1923, when the elder of the father-daughter dental team retired.

Dr. Paxson, whose average weight through the years has been about 100 pounds, built her practice on general work and prosthetics. 'My father would never let me pull teeth,' smiled Dr. Paxson. 'He was afraid I'd strain my hands.' A half-century has seen many changes in dentistry, but Dr. Paxson says there's no danger of a cavity shortage. 'In spite of wider knowledge, I don't find teeth getting any better,' the woman dentist commented.

Last year, Dr. Paxson became the wife of Edward J. Hackemer, a Hamburg concrete supplier. So now, after many years, Dr. Paxson has added household duties to her regular dental activities and her hobby of gardening.

### **Oral Cancer Screening**

The UB School of Dental Medicine will offer its annual free oral cancer screening on June 14 in Squire Hall. The program is targeted at smokers and those over 50, but screening will be available to all. The screening process will involve a 15-minute examination of the soft tissue in the mouth to look for suspicious lesions, and an additional 15 minutes to complete paperwork.

The program is being organized by dental students in conjunction with Lance Ortman, DDS, associate dean of clinical affairs; Lida Radfar, DDS, assistant professor of oral diagnostic sciences, and the faculty of the Dept. of Oral Diagnostic Sciences.

### Poor Oral Health Adds to the Disease Burden of Alcoholics

Alcohol abuse, alone a detriment to health, appears to lead to periodontal disease, tooth decay and mouth sores that are potentially precancerous. In a pilot study of the oral health of patients in alcohol rehabilitation, UB researchers found that more than 80% of the group had moderate-to-severe gum inflammation, more than 2/3 had heavy accumulations of dental plaque and nearly 80% had decayed teeth. More than 1/3 had mouth lesions that were potentially precancerous.

"Persons who abuse alcohol are at high risk of having seriously deteriorated teeth, gums and compromised oral health in general," said co-author Sebastian Ciancio, DDS, SUNY Distinguised Service Professor and chair, Dept. of Periodontics and Endodontics.

Based on these findings, researchers are planning to conduct a larger study of oral health among alcoholics and to develop rational measures for preventing oral disease in this population.

Results of the study were presented at the American Association of Dental Research meeting in San Antonio by Marcelo W.B. Araujo, DDS, research associate in the Dept. of Periodontics and Endodontics and the study's lead author. Additional authors were Kurt Dermen, PhD, senior research scientist in UB's Research Institute on Addictions (RIA); Gerard Connors, PhD, RIA director, and Dennis Lalonde, an RIA research associate.

The study was funded by the UB Center for Dental Studies, RIA, and Pfizer, Inc.

# **UB Study Links Gum Disease with Oral Cancer Risk**

Dental researchers from UB have found a significant association between one measure of periodontal disease and oral pre-cancerous lesions and tumors. Analyzing data from the Third National Health and Nutrition Examination Survey, researchers found that persons with serious periodontal disease were at double the risk of having a pre-cancerous lesion and at four times the risk of having an oral tumor of any kind than persons without serious gum disease.

This is the first finding of a potential link between oral cancer and oral infection," said Sara Grossi, DDS, a co-author on the study, "but there is evidence of an infection link in other cancers." She noted research showing an association between H. pylori and stomach cancer, human papillomavirus and cervical cancer, and cytomegalovirus and Kaposi's sarcoma.

'The potential implications of this association of gum disease and oral cancer is enormous," said Grossi, clinical assistant professor of oral biology in the School of Dental Medicine. "Survival from oral cancer, as with most cancers, depends on the stage of the disease at diagnosis. If further studies demonstrate that periodontal disease is a significant risk and a warning sign, screening and examinations for oral cancer can be targeted in order to improve prevention and early detection of oral cancer."

The first author on the study, Mine Tezal, is a doctoral student in dental epidemiology affiliated with Dr. Grossi's lab. Additional researchers were Alex Ho, oral biology statistician, and Robert J. Genco, DDS, PhD, SUNY Distinguished Professor, former chair of the Dept. of Oral Biology, now director of UB's Office of Science, Technology Transfer and Economic Outreach.

Results of the study were presented at the American Association of Dental Research meeting in San Antonio.
