Greetings From Dean Buchanan

More than six years ago, the School of Dental Medicine committed to a major innovation in educational methodology and curriculum development by initiating the planning phase of the Electronic Curriculum Project. The initial goals of this ambitious project included facilitating: (a) student access to all required textbooks, manuals and the like, (b) access to a wider variety of supplemental curriculum materials, (c) timely updates of curriculum materials, (d) access to course content such as lecture slides and notes and course syllabi, (e) remote access to various clinical support systems, and (f) compliance with copyright requirements. Implementation began here and at one other school in 2000. In this, the fourth year of the implementation phase, the Class 2004, otherwise known affectionately as the Charter DVD Curriculum Class, will graduate. I thought you might be interested in learning of the outcomes of this intriguing project from both the faculty and student perspectives. Some of the most significant results are listed below.



- predoctoral students in all four classes now have laptop computers and all have the Curriculum DVD
- five dental schools have joined UB and the other charter school in implementing the Curriculum DVD
- 13 other schools have initiated the use of laptop computers
- our students enjoy wireless Internet access throughout dental school and university classrooms
- · our students can access lecture slides, course outlines and their own class notes for review at any time from virtually anywhere
- · excerpts from text books and other source materials can be imported directly into the class notes
- a large inventory of supplemental curriculum materials, including videotapes and other references, has been incorporated in the DVD
- the DVD has facilitated increased use of Blackboard by faculty to provide just-in-time curriculum content
- students enjoy remote access from home and elsewhere to clinical software systems for treatment planning, patient scheduling, instrument ordering, and clinical progress tracking
- · use of microscopes in histology and oral histology laboratories has been replaced by computer laboratories
- dietary analysis software has been incorporated into the nutrition curriculum
- self-paced learning and testing has been incorporated into the dental anatomy curriculum
- the neuroanatomy course is now partly web based
- · the clinical dentistry curriculum is supported by server based distribution of PowerPoint lecture notes
- the Class of 2004 ranked 7th among 56 schools in National Board Part I performance the highest ranking in recent years
- the Class was well above the national average performance on the National Board Part II
- the Class also enjoyed a high placement rate in highly competitive postgraduate programs through the Match system

Some of the more revealing comments concerning the Electronic Curriculum made recently by our students are summarized below.

- "I saw major advances and improvements in the technology tools used in the dental curriculum.... that have greatly enhanced the ease of learning new material whether it be clinically or didactically."
- "As senior dental students, we are able to use the DVD not just for reading assignments but for directed searches, for procedural help, and clinical information."
- "The wireless Internet capabilities throughout the school and library are terrific and make our laptops indispensable"
- "Technology has had a positive effect on my dental school experience."
- "I also like how professors can post the lectures online, as well as any supplemental information. I have enjoyed being able to check academic performance online as well."
- "Having computers with the DVD software on them in the clinic has also been very helpful. Multiple times I have used the computers to look up techniques or materials, and I think that having them in the clinic is a great idea."
- "Overall, I feel that technology has been an asset to our dental education. It is difficult to imagine how different our experience would be without it."

Alan Drinnan, DDS, MD

Obituary


Dr. Alan Drinnan, SUNY Distinguished Service Professor Emeritus in the Dept of Oral Diagnostic Sciences of the UB School of Dental Medicine died unexpectedly on January 8, 2004 at home. He was 71. Dr. Drinnan had been one of the key members of the UB faculty for over 40 years.

Alan Drinnan grew up in Bristol, England and received both his dental and medical degrees from the University of Bristol. While still in England, he served as a Dental Officer in the British Army, ran a private dental practice, taught oral surgery on the faculty of the University of Bristol, and became a Fellow of the Royal College of Surgeons of England.

Upon coming to Buffalo in 1962, he studied oral & maxillofacial pathology and was quickly recruited for the UB faculty on a full-time basis. He subsequently received his DDS degree from

UB, completed a medical internship at the Buffalo General Hospital, became a Diplomate of the American Academy of Oral & Maxillofacial Pathology, Chairman of the Dept of Oral Medicine, Director of the Dental Dept of Buffalo General Hospital, and a U.S. citizen.

In between these activities, Dr. Drinnan also found time to host regularly scheduled public affairs programs on WKBW-TV and WNED-TV, moderate several public policy debates and discussions on local television, serve on the Erie County Sheriff's Scientific Staff, serve as President of the American and the International Association of Oral & Maxillofacial Pathologists and as a consultant to the Armed Forces Institute of Pathology, World Health Organization,



Federation Dentaire Internationale, American Dental Association, American Association of Dental Schools, Erie County Medical Examiner's Office, and UB's Public Radio Station WBFO.

He was also a recognized authority in forensic dentistry, had sabbatical leaves in both Melbourne, Australia and Papua New Guinea, and lectured in many countries on every continent in the world.

Dr. Drinnan also began the Internet Bulletin Board for Oral Pathology (BBOP), which currently has 700 subscribers all over the

world and serves as a clearinghouse for issues related to service, teaching and research.

As a result of his contributions, the State University of New York Board of Trustees promoted Dr. Drinnan to the rank of SUNY Distinguished Service Professor in 1994. In addition to these many achievements, Alan Drinnan was a musician, and was very well known for his outstanding ability as a speaker and teacher, as well as for his well honed 'British' sense of 'humour.'

He is survived by his wife Rita, son Dr. Michael Drinnan, daughter-in-law Dr. Caroline Drinnan, daughter Julia Drinnan-Doran, son-in-law Tom Doran, sister Pamela Drinnan, and grandsons Andrew, Jonathan, Alex and Jake Drinnan.

The Department of Oral Diagnostic Sciences has formed a committee to raise funds for the purpose of establishing a memorial tribute to our late colleague, Alan Drinnan. The type of tribute to be created will depend upon the amount of funds that becomes available. To date, the following possibilities have been suggested: 1) an endowed professorship in oral pathology or oral medicine; 2) a scholarship for one or more oral medicine or oral pathology residents or fellows; or 3) dedication of a physical facility in the dental school, e.g. a conference room, a clinical area, etc. Anyone with a suggestion or opinion regarding an appropriate tribute for Alan Drinnan should contact Dr. Terrence Thines (telephone: 716-829-2051; fax: 716-829-3554; e-mail: tjt@buffalo.edu)

Dr. Alan Drinnan

Rarely in life are we honored to know a person who has touched so many with his wit, charm and intellect. Rarely do we meet someone with the energy of ten people who is able to touch our lives in such a personal way.

On January 8, 2004, unexpectedly, that person was taken from us, his life's journey abruptly ended. Dr. Alan Drinnan, SUNY Distinguished Service Professor Emeritus in the Department of Oral Diagnostic Science of the UB School of Dental Medicine was gone after 40 years of distinguished service to the University at Buffalo family.

Throughout Dr. Drinnan's life he was bestowed many honors and blessed by many achievements. Starting in Bristol, England his hometown where he received both his medical and dental degrees from the University of Bristol. He also served as a Dental Officer in the British Army, ran a private dental practice, taught oral surgery and became a fellow at the Royal College of Surgeons of England.

In 1962 he came to Buffalo where we quickly realized we better not let him go back over the pond and made him a full-time faculty member at UB. He received his DDS from UB and completed a medical internship at Buffalo General Hospital, became a Diplomate of the American Academy of Oral Maxillofacial Pathology, Chairman of the Department of Oral Medicine, Director of the Dental Department of the Buffalo General Hospital, and a US citizen.

Even though Dr. Drinnan achieved so many honors and accomplished so much, personally his greatest attribute was his zest for life and how he conveyed that to everyone he met. He was a wonderful orator and a great conversationalist, coupled with his fantastic sense of humor and personal charm, he was someone you wanted to learn from.

Thank you to his wife Rita and his wonderful family for sharing him with us. The world was definitely a better place with Dr. Drinnan in it. Students to come will never know just how much they missed.

Robert J. Genco, DDS '63 is Interim U.B. Provost

In a key appointment, UB President John B. Simpson named Robert J. Genco as UB's interim No. 2 official. Dr. Genco, a vice provost who oversees UB's efforts to commercialize faculty research, became interim provost effective Feb.1. He'll be an active participant and a critical participant in the management of the university," Simpson said.

Genco succeeds Provost Elizabeth D. Capaldi, who left for a position as State University of New York vice chancellor and New York vice chancellor and chief of staff.

Simpson said Genco will likely serve as interim provost for about six months while UB conducts a national search for a permanent replacement for Capaldi. Genco will be expected to provide a sense of stability after the departure of Capaldi and former President William R. Greiner. Genco must continue ongoing initiatives while tackling new issues such as the creation of next year's budget.

Genco is well-regarded as a SUNY distinguished professor in UB's School of Dental Medicine. He has worked at UB for 36 years. "He's an excellent academic, a superb researcher and all that. But he also has a good sense of academic priorities. He's a good administrator," said Stephen C. Dunnett, vice provost for international education.

Since 2001, Genco has been director of UB's Office for Science, Technology Transfer and Economic Outreach, leading the school's effort to translate faculty research into commercial products and new jobs.

Genco said he doesn't intend to seek the permanent job of provost.

Learn An Expedited, Comprehensive Approach to Edentulism

Guest Faculty: Dr. Lyndon Cooper DDS, PhD is Stallings Distinguished Professor of Dentistry, Dept of Prosthodontics at the University of NC at Chapel Hill. He is the Director of Graduate Prosthodontics and the Bone Biology and Implant Therapy Laboratory. Dr. Cooper is a Diplomate of the American Board of Prosthodontics and serves on the American College of Prosthodontics Board of Directors. Dr. Cooper's laboratory focuses



on bone biology, adult stem cell bone regeneration, and clinical evaluation of dental implant therapies. Their research findings have been presented in over 50 publications and in more than 100 national and international presentations. These efforts integrate basic and clinical research to improve patient care.

School News

Improving Patient C.A.R.E.

The Counseling, Advocacy, Referral, Education and Service (CARES) Program was established in 2001 by the Schools of Dental Medicine and Social Work. Since the program's inception, about 400 patients have received social work intervention.

The CARES Program has five sub-programs: (1) free social work services for school patients (2) free cognitive behavioral social work for patients suffering with temporomandibular joint disorder (3) biobehavioral dental student education with focus on assisting marginalized patients (4) masters of social work student field education (5) community outreach services to older adults attending senior centers in Erie County.

By offering these services in the SDM, we aim to improve patient retention rates in the clinic. Patients referred to CARES are assessed by a social worker for any biopsychosocial barriers to receiving dental care. The majority of patients referred for social work assistance were females (66%) or retired/disabled (62%). The biopsychosocial barriers that SDM patients commonly seek a CARES social workers assistance for include: finances (49%), health-related concerns (33%) such as physical disabilities, caregiving responsibilities and limited access to general health care, transportation (20%), mental health and family concerns (20%), and housing issues (12%).

Since the inception of the CARES Program, there has been a 26% decrease in the dental clinic's discharge rate, with 80% of CARES patients being retained by the SDM. Further, there has been a 9.3% increase in new patients. Prior to receiving social work assistance, patients enrolled in the CARES Program spent an average of \$325 for dental treatment at the SDM. Following the initiation of social work assistance, patients enrolled in the CARES Program spent an average of \$540 for dental treatment at the SDM. Subsequently, the SDM has seen an increase of approximately \$215 in revenue from each patient seen by the social worker. When the sum of these patient's dental treatments is calculated from their CARES Program start date, the Program has assisted in \$154,500 of SDM revenue over the past two and a half years.

Despite these promising results, there are some patients that we are unable to reach, primarily those that are not eligible for Medicaid, but whose income is insufficient to afford additional dental treatment costs. In order to address this, the CARES Program is creating a fund to provide dental services to those living in financial disparity. All funds received through fundraising efforts will be utilized by patients living up to double the poverty rate (e.g.: \$642 - \$1284 in monthly income for one person living alone). To ensure the legitimacy of this process, social workers will request proof of income in order to determine if a patient is eligible to receive financial assistance for their dental care. These pictures depict a range of art works that show various degrees of dental and facial pain, ranging from a walrus ivory chess figure dating from the twelfth century to twentieth century grotesques carved into the stone walls lining the Grand Courtyard of the University of Queensland, Brisbane, Australia. We hope that you find these pictures and details about them of interest.


A misericord is a narrow ledge on the underside of a hinged seat in the choir in the choir of a monastic chapel. When the seat was turned up, the ledge permitted one to relax while standing up! The name is derived from miseri, to pity, and cors (cordis), the heart; it relaxed the rules and took pity on the heart! This ecclesiastic art form lent itself very well to the imaginations of artists, and it was very common for the woodworkers of the day to embellish the misericord ledges with many different carvings. The one shown here is from Ely Cathedral in Eastern England. The cathedral dates from the 11th century and is considered one of the finest and most beautiful cathedrals in the British Isles. This misericord under one of the


choir seats shows a fanciful figure practicing dentistry. Reproduced by kind permission of the dean and chapter of Ely Cathedral.

One of the most attractive examples of a stone carving of 'toothache' may be seen in the beautiful 12th century Wells Cathedral in the southwest of England. This carving of a man apparently in pain, pulling his mouth open and pointing to the offending tooth, is in the south transept of the church. It is a 'capital,' that is, the ornamental



This chess figure, a queen from the Isle of Lewis chess set currently in the British Museum in London, looks anxious and in some distress and appears to be massaging her face – perhaps to assuage some facial pain. The precise origin of these chess pieces is unknown. They were discovered in 1831 on the deserted Atlantic coastline of the Island of Lewis in the Outer Hebrides of Scotland. They are generally assumed to be Scandinavian, perhaps of Icelandic origin, dating from about 1150.

Alan J. Gross Fund

The Alan J. Gross Fund was created in 1998 to honor Dr. Alan J. Gross, a well-liked and highly respected faculty member who was also a passionate student advocate. The general purpose of the Fund is to enhance the environment of students at the UB School of Dental Medicine. The committee that oversees spending initiatives for the fund is comprised of Student Affairs representatives, students, and members of Alan Gross's family.

White Coat Ceremony: Since 2000, the school has welcomed new dental students into the profession by means of a White Coat Ceremony. This ceremony takes place during convocation, at the beginning of the school year. The ceremony is a highlight for new students as well as for their families. The Fund sponsors a continental breakfast and the coats distributed during the ceremony.

Family Day: The Fund covers the cost of a lunch held on the day of Phase II of the dental match, when most students find out where they will be doing a residency in the coming year. This luncheon is a time of celebration for the students and is always well attended.

The Alan Gross Award for Excellence in Teaching: This teaching award was created in 2002 and is awarded to faculty in the first, second, and third years of the dental curriculum. The award was developed to honor Alan's memory and the commitment he made to teaching excellence. The award is made on the basis of enthusiasm for the subject matter, the ability to convey information clearly, and a genuine concern for students.

Talent Show: The annual Talent Show is an event that has become a tradition and which would not have become a reality without Alan's enthusiasm and support. This family event is well attended, with the eighth annual show just having been completed. The Fund supports videotaping of the event and the making of copies distributed to performers. Additional tapes are made available to the dental school community at cost.

Fund Raising Activities: In the summer of 2000, Alan's brother Gordy Gross biked cross-country (over 3,000 miles) to raise money for the fund. Dubbed the 'Tour de Gordon,' the event raised over \$50,000 for the fund. In September 2000, a Dental Dash one-miler foot race was held on the university's south campus in Alan's honor. A second race was held in April 2002.

On Sunday May 23, 2004, the 1st annual Dr. Alan Gross Memorial UB Classic bicycle race will take place. Starting at 9 am and racing around the approximately 1.25 mile Putnam Way, both professional and amateur racers will compete in their appropriate age and riding categories. These events all share a common thread - they represent areas of great passion for Alan. He was devoted to students and student issues, and would have been proud to know that the fund has supported so many activities to enhance the quality of student life.
